MINUTES OF THE MEETING HELD ON 19th DECEMBER 2022

33/2022 PRESENT. Councillors, Woolley, Corble, Mudford and White attended the meeting.

34/2022 APOLOGIES FOR ABSENCE. Resolved to note that County Councillor Spencer and District Councillor Elliott gave their apologies. Councillor Scoggins also gave apologies for absence.

35/2022 APPROVAL OF THE MINUTES. Resolved that the minutes of the meeting held on the 7th November were a true and correct record with the amendment that Minute Number 28/2022 – the number of surveys distributed was 92. Councillor White signed the minutes.

36/2022 DECLARATIONS OF MEMBER INTEREST. There were no declaration of member interest at this meeting.

37/2022 PUBLIC SPEAKING. Resolved to note that there were no members of the public at the meeting.

38/2022 VILLAGE SURVEY. Councillor Mudford gave an initial overview and reported that 63% of completed surveys were returned. Varied issues were raised and Chris Woodhouse has agreed to compile the survey and a presentation will be held at a future date.
