**229/2023 VARIATION OF ORDER OF BUSINESS.** Resolved to note that there were no variations of the order of business.

**230/2023 PUBLIC SPEAKING.** Resolved to note that the Clerk gave an update on the Parish Council's interest in having belly bins in the village. The café owner read out a report to the Council.
