MINUTES OF THE MEETING HELD ON MONDAY 5th AUGUST 2024

335/2024 PRESENT. Councillors White, Corble and A Woolley attended the meeting.

District Councillor Mellstrom attended the meeting from 7.20 pm

336/2024 APOLOGIES FOR ABSENCE. Resolved to note that Councillors P Woolley and Mudford gave apologies for their absence.

337/2024 DECLARATIONS OF INTEREST. Resolved to note that there were no Declarations of Interest at this meeting.

338/2024 VARIATION OF ORDER OF BUSINESS. Resolved to note that there was no variation of the order of business.

338/2024 PUBLIC SPEAKING. Resolved to note that the District Councillor gave a report to Council. She reported that there is a report available from Derbyshire Dales District Council regarding areas identified for permanent Traveller Sites. The District Council is looking at planning for second homes and holiday lets. The District Council plan is now available to view and sets out their targets. It was also reported that the toilets facilities at Monsal Head have been taken back by Derbyshire Dales District Council who will take the responsibility for them.

340/2024 CHAIR'S REPORT.

- a) The Parish Council are proceeding with the registration of all the land which the Parish Council owns. A solicitor has been engaged to undertake this process.
- b) Request from a resident for a further speed restriction on Tagg Lane. It was reported that replacement signage has been put in place. The Chair is to contact Derbyshire County Council regarding this matter. Councillor Corble is to investigate further signage to identify an alternative route for people to walk along.
- c) A member of the public has queried the potential engagement of youth with the Parish Council. This is a matter which will be considered.
- d) Dangerous railings outside the school – this has been reported to Derbyshire County Council.
- e) PCSO from Staffordshire Police has enquired about the Parish Council A Boards and potentially to purchase some. The details will be passed to the officer.

f) New replacement football nets -as this is also used as a Community facility the Parish Council, on Council owned land, can purchase the replacements.
